I was present last night when you announced that you wouldn't go forward with the landfill for Moncure. Thank you! I can't tell you how upset I was, especially at the thought that the commissioners I had helped elect (Pollard and Atwater) would allow such a thing even to be considered. I am reassured now, but you risked a lot of credibility even going so far. My trust needs continuing reassurance that you are concerned with the safety and health of the residents in Moncure, who are being poisoned by some plants operating here now, and are at greatest risk (within 10 mile zone) of the Shearon Harris stockpile of nuclear waste, already having 10 times what was released at Chernobyl of the especially destructive Cesium 137. 
