Dear Mr. Warthen:

This is to inform you that the U. S. Nuclear Regulatory Commission (NRC) has selected the Marriott Library, University of Utah, to serve as the official local public document room (LPDR) for records pertaining to the proposed independent spent fuel storage installation (ISFSI) to be built on the Skull Valley Goshute Indian Reservation by Private Fuel Storage Limited Liability Corporation (PFS).

The LPDR collection will be set-up once the expansion project at your library is completed. In the meantime, as we discussed yesterday on the telephone, I am sending you, under separate cover, eight (8) boxes of microfiche. This microfiche includes cards numbered 52000 through 93569 and should not be opened until the microfiche cabinets, we are purchasing for you, are received. The remaining microfiche beginning with card number 93570 will be sent out later.

I will also be sending you a box with miscellaneous reference materials. This box should be held until Teresa Linton, our Information Services Librarian, visits your library to set-up the LPDR collection and provide staff training.

Once the LPDR collection is set-up and training is complete, a Federal Register Notice will be published informing the public that the collection is available for use.

I have enclosed a copy of the self-evaluation form that you completed over the telephone yesterday.
