Gentlemen:

Via reference 1 TXU Electric submitted proposed changes to the Technical Specifications associated with steam generator repair using laser welded sleeves at CPSES Unit 1. After review of the proposed changes the NRC staff requested additional information via reference 2. TXU Electric provided the requested information via reference 3. In reference 4, TXU Electric provided a commitment related to the hydraulic equivalency of sleeves to plugs for tubes with laser welded sleeves.

On January 23, 2001, during a telephone conversation, the NRC Staff discussed the TXU commitment concerning the hydraulic equivalencies of sleeves to plugs. The NRC indicated that this aspect of TXU Electric's license amendment request would require in depth review prior to granting an approval. In order to obtain approval prior to the upcoming CPSES Unit 1 outage, TXU Electric will use a hydraulic equivalency ratio of four (4) sleeved tubes to one (1) plugged tube when calculating Steam Generator Tube Plugging (e.g., if 4 tubes are sleeved, this will be considered the same as one plugged tube) and the number of sleeved tubes in any one steam generator will be limited to 50% of the allowed Steam Generator Tube Plugging. Currently the Unit 1 steam generators are limited to 10% Steam Generator Tube Plugging. Based on the commitment above, the plugging for any one steam generator due to sleeved tubes will not exceed 5% for Unit 1 only.

This commitment is being made without prejudice to the current licensing basis for CPSES or the proposed equivalency ratios provided in reference 1. It is TXU Electric's understanding that the NRC staff intends to review the ratios proposed in reference 1 in a timely manner. TXU Electric continues to believe that the ratios provided in reference 1 for CPSES are appropriate and will be found acceptable by the NRC.

This communication contains the following new commitments which will be completed as noted:

27219	TXU Electric will use a hydraulic equivalency ratio of four (4) sleeved tubes to one (1) plugged tube when calculating Steam Generator Tube Plugging and the number of sleeved tubes in any one steam generator will be limited to 50% of the allowed Steam Generator Tube Plugging.

The commitment number is used by TXU Electric for the internal tracking of CPSES commitments.




