**PROGRAM MANAGEMENT INFORMATION: TECHNICAL CONFERENCING FORUM-
REQUEST FOR COMMENTS ON PART 40 DRAFT PROPOSED RULEMAKING PLAN
(STP- 01-007)**

The U.S. Nuclear Regulatory Commission (NRC) is in the process of developing a rulemaking plan to address the distribution of source material to persons exempt from licensing and to general licensees, in a manner intended to make Part 40 in Title 10 of the Code of Federal Regulations (CFR) more risk-informed.

A draft proposed rulemaking plan, "10 CFR Part 40: Distribution of Source Material to Exempt Persons and to General Licensees and Revision of § 40.22 General License," has been uploaded to the Technical Conference Forum (TCF). Your review and comment are invited on this draft by March 2, 2001. The draft proposed rulemaking plan addresses options to revise 10 CFR Part 40. In particular, we are interested in whether Options 4 and 5 are sufficiently distinct to warrant separation, or whether they should be combined.

Additionally, we are requesting the Organization of Agreement States and the State of Colorado to comment on the acceptability of the staff's plan to resolve their previously submitted petition for rulemaking (PRM 40-27) or if they believe that it should be handled separately from this rulemaking effort.

Finally, two sections, "The Office of General Counsel (OGC) Legal Analysis" and "Application of Risk-informed Screening Criteria" are incomplete at this time. The first item is a legal analysis of the proposed rulemaking plan by our OGC. The second item will be a summary of how this rulemaking plan will meet the newly instituted screening criteria in the Office of Nuclear Material Safety and Safeguards (NMSS) for new actions. The omission of these sections should not impact any comments that you may have.

The TCF can only be accessed by the Agreement States having a unique user name and password, which were last updated via All Agreement States letter SP-99-027. Please provide any comments on the draft directly to Gary C. Due to its pre-decisional nature, this document is exempt from public disclosure under NRC rules. We request that you limit distribution to your staff and not release the document publicly.
