The United States Nuclear Regulatory Commission, with the United States Department of the Interior's Bureaus of Indian Affairs, and Land Management Will Hold Two Scoping Meetings April 29, 1999 on Aspects of the Environmental Impact Statement For The Proposed Private Fuel Storage Facility

The purpose of these meetings is to provide an opportunity for the public to comment on the scope of the Nuclear Regulatory Commission's (NRC's) Environmental Impact Statement with regard to: (1) the alternate transportation route proposed by Private Fuel Storage, L.L.C., on Bureau of Land Management (BLM) land along the base of the Cedar Mountains, and (2) the lease agreement between the Private Fuel Storage and the Skull Valley Band of Goshute Indians. BLM and the Bureau of Indian Affairs have agreed to be cooperating agencies with NRC in the development of this EIS.

A Copy of NRC's September 28, 1998, EIS Scoping Report can be viewed at the NRC Local Public Document Room at the University of Utah, Marriott Library, Documents Division, 295 S. 1500 East, Salt Lake City, Utah. A limited number of copies of NRC's scoping report will be available at the meetings.

Written comments may be submitted to Mr. Scott Flanders, Mail Stop O6F18, Spent Fuel Project Office, U.S. Nuclear Regulatory Commission Washington, DC 20555. Comments will be accepted before the meetings and until May 28, 1999.
