We are reviewing your submittal on this subject (your letter dated 10/16/00, NMP2L 1990). Our PRA reviewer Stephen Dinsmore has the following questions/comments that he would like to discuss with you in a conference call. Our engineering reviewer Shou-Nien Hou will also participate in the call, but he does not currently have questions.

- 1) Have the hardware and procedural modifications credited in the IPE been done yet (they were scheduled for the 1993 refueling outage);
- 2) A discussion on the how the IGSCC inspections are credited in the change in risk calculations.

These questions/comments do not at this time constitute a formal NRC position, nor do they formally ask for information. In the conference call we will discuss their disposition, i.e. there may or may not be a formal issuance after the phone call.
