The Nuclear Regulatory Commission (NRC) recently issued two orders transferring the Indian Point 3 and FitzPatrick operating licenses from the New York Power Authority (NYPA) to Entergy Nuclear Operations, Inc. (ENO) (References 1 and 2, respectively). As a result, ENO



requests that the NRC transfer outstanding applications and other initiatives submitted by NYPA, for either the Indian Point 3 or James A. FitzPatrick nuclear power plants, to ENO. ENO also requests that activities and correspondence concerning Indian Point 3 or FitzPatrick reflect the transfer of these operating licenses.

A number of issues and requests associated with the operating licenses were pending with the NRC at the time of the license transfer. ENO Inc. hereby adopts such issues and requests made by NYPA for Indian Point 3 and FitzPatrick prior to the license transfer.
