This document is one of the key implementation tools of the reactor safety SDP in the reactor oversight process and is also publicly available through the Nuclear Regulatory Commission (NRC) ADAMS system.

The 1999 Pilot Plant review effort clearly indicated that significant site-specific design and risk information was not captured in the Phase 2 Worksheets forwarded to you last spring. Subsequently, a site visit was conducted by the NRC to verify and update plant equipment configuration data and to collect site-specific risk information from your staff. The enclosed document reflects the results of this visit. The Phase 2 Worksheets in the enclosure have incorporated much of the information we obtained during our site visits. The staff encourages further licensee comments where it is identified that the Worksheets give inaccurately low significance determinations. Any comments should be forwarded to the Chief, Probabilistic Safety Assessment Branch, Office of Nuclear Reactor Regulation (NRR). We will continue to assess SDP accuracy and update the document based on continuing experience.

While the enclosed Phase 2 Worksheets have been verified by our staff to include the site specific data, we will continue to assess its accuracy throughout implementation and update the document based on comments by our inspectors and your staff.
