


The purpose of this modification is to: (1) increase the maximum ordering limitation amount for the task ordering portion of the contract by \$346,740; (2) increase the obligated amount of the contract by \$339,840 to allow for payment of the fixed monthly price accounting services for eight (8) months, per Subsection A.1 of the contract as follows: \$140,000 for Commercial Payment Transactions; \$38,640 for Federal Payment Voucher Tracking; and \$161,200 for Debt Collection; (3) extend the period of performance for the remaining eight (8) months of Option Period Four under the contract; (4) increase the total contract award amount by \$339,840 for the fixed monthly accounting services and \$346,740 for the task ordering portion of the contract; and, (5) corrects the summary of obligations under the contract. Accordingly, the contract is hereby modified as follows:

1. Under Subsection A.2, "CONSIDERATION AND OBLIGATION-TASK ORDERS," paragraph a, first sentence, is revised to read as follows:

"a. The maximum ordering limitation (ceiling) for products and services ordered, delivered and accepted under this contract is \$3,345,250."
2. Under Subsection A.4, "CONSIDERATION AND OBLIGATION-FIRM FIXED PRICE (JUN 1998)," paragraphs a. and b., are revised to read as follows:

"a. The firm fixed price (ceiling) for providing monthly accounting services is \$1,960,320.

b. The amount currently obligated by the Government with respect to the monthly fixed price services is \$2,468,685. (Note: This total amount includes \$1,960,320 for the monthly accounting services and \$508,365 previously obligated under the basic contract for task orders)."
3. Under Subsection B.9 entitled, "ORDERING (OCT 1995)," the period of performance to issue orders under the contract is extended through September 30, 2001. Accordingly, the last sentence in paragraph (a) of subsection B.9 is deleted in its entirety and replaced with the following:

"Such orders may be issued from February 1, 2001 through September 30, 2001."
4. As a result of exercising the remaining 8 months of Option Period Four, the total contract award amount (ceiling) is increased by \$686,580 (\$339,840 for the monthly accounting services and \$346,740 for task orders) from \$4,618,990 to \$5,305,570. Therefore, on page 2 of SF 1449, Block No. 26, the amount is revised to \$5,305,570.

All other terms and conditions of this contract remain unchanged.

A summary of obligations from award date, through the date of this action is given below.
