**Subject:** Comments on preliminary review of your license transfer submittal

Jay Silberg, Steve Leonard, John Dosa:

We have taken a cursory look at the license transfer application and have some comments (below). We would like to hold a conference call with you and others in the near future. The following comments/questions do not currently convey a formal NRC position, nor do they formally request for additional information. In the conference call, we will discuss the disposition of these comments/questions.

1. In contrast to the Calvert Cliffs application, where an affiliate of NMP LLC will acquire that plant, the Nine Mile Point application doesn't seem to have the same discussion on the Virgo investment. The Virgo investment is being noticed in Calvert as a possible indirect transfer; is the same deal being envisioned for Nine Mile Point?
2. The application summarizes some of the necessary findings in indirect transfer language, rather than direct transfer language. The application should really restate that the proposed transferee will be technically and financially qualified, rather than state that the "proposed transaction . . . will not affect the technical or financial qualifications of the licensed operator of these units." (See cover letter at 4).
