DISTRIBUTION OF URANIUM PLATES  
SHEARED AT JESSOP STEEL COMPANY  
MARCH 2, 1954

Gentlemen:

Confirming my telephone conversation with Ken Gelling of your office, we are attaching a chart which indicates our recommended distribution plan for the sections sheared at Jessop Steel Company on March 2. Sections which are not shown in the distribution plan should be retained for further consideration.

All plates to be sent to SRL should be identified and the sample sections removed as outlined in our letter DPW-54-159. The sample sections from these plates should be sent to AM&F.

The 16 foot sections to be sent to AM&F should be edge machined to 3.1 inch width with the corners of the machined edges broken to a 1/32 inch radius.

The arrangements for the heat treatment of the indicated sections are being made by R. J. Delagi.

All shipments to SRL of material from the February 22 rolling at Superior Steel Corporation should bear the purchase order number AX-3104.
