Subject: LaSalle County Station Security Plan, Revision 65

In accordance with 10 CFR 50.54(p)(2), "Conditions of licenses," we are submitting changes to the Exelon Generation Company (EGC), LLC, formerly Commonwealth Edison Company, LaSalle County Station Security Plan. In accordance with 10 CFR 50.4(b)(4), "Security plan and related submittals," attached are the original and three (3) copies of Revision 65.

Revision 65 includes the following changes.

The Security Plan has been revised to replace/modify the description of the security organization with a new organizational structure. New descriptions have been added for Corporate Nuclear Security, the Regional Operating Group (ROG), and Site Nuclear Security. Other changes, including position and title name changes, were also required. All changes are considered editorial and were made due to the company's reorganization resulting from the merger between Chicago-based Unicom Corporation and Philadelphia-based PECO Energy Company.

As required by 10 CFR 50.54(p)(2), we have concluded that these changes do not decrease the safeguards effectiveness of the LaSalle County Station Security Plan.

The changes to the LaSalle County Station Security Plan were implemented on December 10, 2000. In accordance with 10 CFR 50.54(p)(2), this change shall be reported within 60 days of implementation (i.e., February 9, 2001).
