Please find enclosed, information supporting our application for a Radioactive Materials License for: Governor Juan F. Luis Hospital and Medical Center in Christiansted, St. Croix, U. S. V.I.

Evidence of continuing education for Dr. Andre Galiber and Dr. Angelo Galiber is attached. Each physician has been actively practicing Radiology/Nuclear Medicine since Board Certification.

Work experience as required for Dr. Griffith is being pursued at his Institution. We will submit his name for authorized user status at a later date.

It is requested that each authorized user be granted authorization to use materials listed in 35.100 and 35.200.

The Mo99-Tc99m generator will be kept in the lead lined shield as supplied by the manufacturer. The generator will be stored on the floor next to the lead-lined trashcan.

Lead shielding is available in the hot lab area. A lead lined L-shield as well as lead bricks will be used. This will also allow us to have a shielded area for dose prep and storage. Leaded vial shields, leaded syringe shields will be used. Long handled forceps will be available, as will disposable rubber gloves and other associated safety devices as needed and or directed by the Radiation Safety Officer.

We wish to utilize DTPA Aerosol for lung ventilation studies. We will use a single use shielded device, commercially available. These units once used will be decayed in storage prior to disposal.

We will use our Gamma Camera for wipe test analysis. Calculations showing the MDA is sufficient to detect 2000 dpm will be available.

If Dr. Andre Galiber, Jr. CME documents qualify him to be a Radiation/Safety Officer, then Governor Juan F. Luis Hospital will designate him as such. However, if it is more expedient to obtain our material license to have Dr. Dante Galiber as the Radiation/Safety Officer then he will be our designee.
