SYNOPSIS

This investigation was initiated by the U.S. Nuclear Regulatory Commission, Office of Investigations, Region II, on January 13, 2000, to determine whether a senior reactor operator (SRO) deliberately failed to report a felony arrest as required by his employer.

Based on the evidence developed during the investigation, it was not substantiated that the SRO willfully failed to report an arrest to his employer.
