


This modification increases the ceiling amount of the contract by \$73,132 to accommodate increases for Task Orders 9 and 12. Accordingly, the following revisions are made:

1. Block 15A, SF26 is revised to show the total amount of the contract as "\$826,829."

2. Section B.3, first sentence of subparagraph (a) is revised to read as follows:

"(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$826,829."
