Dear Mr. Caves,

I understand that CP & L provided a great deal of information so that Orange County could respond to your plans with the help of scientist Gordon Thompson. Why then did not CP & L encourage the safety hearings so that Thompson could speak about his response to NRC? If CP & L cares about the safety of its employees and neighbors, why doesn't CP & L insist upon safety hearings to reassure us all, and why does CP & L spend \$2 million on lawyers to prevent Gordon Thompson from speaking in a safety hearing? I heard Dr. Thompson say that there were real dangers (1 in a 100 in the nuclear industry in the U.S.) of a pool fire, and that a pool fire could wipe out an area as large as N.C. for 100 years. Why didn't CP & L want him to say this in a safety hearing?

I learned in family therapy that actions speak louder than words. You are a very considerate person, a real human being as far as I can tell, but your corporate employer acts in defiance of public concern. Actions for safety speak louder than words!

Thank you. Please send my message to Mr. Cavanaugh. I hold him, not you responsible. But everyone in the CP & L corporate structure has his conscience to answer to, including the stockholders. I would think your stockholders would wish to have your reputation redeemed by actions to prove your interest in safety. If you persist in pool storage, then you should provide evacuation plans for all of N.C. and post evacuation signs all over N.C., into South Carolina, and into Virginia. There should be emergency planning within 10 miles at least of every train track that carries the irradiated fuel rods through North and South Carolina. I would think it would be wiser even from a corporate profits point of view to insist on safety and to go to dry cask storage. Think about it!


