


This modification is issued to deobligate unexpended funds from the Spare Parts/Cost Reimbursable portion of this contract in the amount of \$98,339.37 which thereby decreases the obligated amount of this contract from \$2,056,955.75 to \$1,958,616.38. Accordingly, the following change is hereby made:

Under Subsection B.4 CONSIDERATION AND OBLIGATION-DELIVERY ORDERS (JUN 1988), the first sentence in paragraph (b) is hereby deleted in its entirety and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to the items listed above is \$746,823.38."
