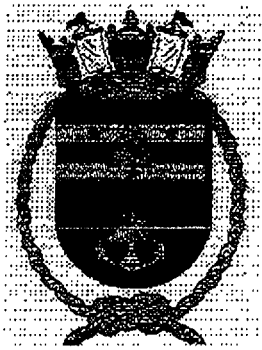

We regret the delay in responding to the information you requested, in regards to the status of the IBIS Indicators supplied by General Nucleonics.

We also confirm our preliminary information provided to you during telephone conversation last week. Five units were returned to General Nucleonics for refurbish/calibration. The material came via United Airlines air waybill 016.7782.2636 via flight number UA988 leaving Rio de Janeiro on 09/22/00 and arriving in LAX via flight UA905 ETA LAX on 09/23/00. These items are now at General Nucleonics for servicing.



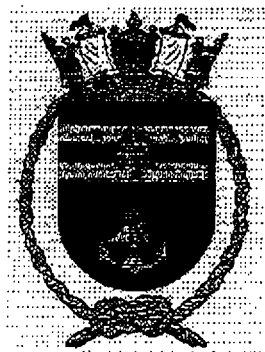


