PURPOSE: To discuss key elements of the decommissioning plan to be developed for the Michigan Department of Natural Resources (MDNR) Site Decommissioning Management Plan (SDMP) site, in Bay County, Michigan.

ATTENDEES: See Attachment A.

BACKGROUND:

The MDNR SDMP site, located in Bay County, Michigan, is part of the former Hartley & Hartley Landfill, and is currently known as the Tobico Marsh State Game Area. The 3 acre landfill site is contaminated with thorium and covered with a 1.5 m (5 ft) thick clay cap and encapsulated with 0.9 m (3 ft) thick bentonite slurry walls. The NRC license (SUC-1581) is for possession only. In accordance with condition 10A of the license, the DP must be submitted no later than August 31, 2001.

DISCUSSION

The NRC staff explained the acceptance and review processes related to the DP. The processes for both unrestricted release and restricted release were described by NRC staff. MDNR staff stated that it plans to submit a DP for unrestricted release. However, the final determination will be based on the outcome of the site characterization and the dose modeling which are currently underway.

Site Characterization

MDNR stated that the site characterization results indicated that the permeability of the clay cap is approximately 10^{-7} cm/sec to 10^{-8} cm/sec which is fairly impermeable. The area is marshy and there is some contamination below the water table. The site is not a Resource Conservation and Recovery Act facility under the U.S. Environmental Protection Agency regulations. The site is subject to State of Michigan environmental remediation statutes. Water samples taken from on site monitoring wells do not contain thorium.

Dose Modeling

The staff discussed Appendix C (Technical Basis for Dose Modeling Evaluations) to NUREG-1727, "NMSS Decommissioning Standard Review Plan." Discussion topics included scenarios, pathways, parameters, default distributions, and derived concentration guideline (DCGL)

values. Related discussion topics included the use of the computer codes RESRAD and D&D, NUREG-5512 (Volume 3), "Residual Radioactive Contamination From Decommissioning: Parameter Analysis, Draft Report for Comment", NUREG-1575, "Multi-Agency Radiation Survey and Site Investigation Manual," and the licensee's final status survey report.

According to the MDNR staff, preliminary dose assessment results performed so far appear to support unrestricted release without the need to excavate or remove any material. However, the MDNR staff also stated that there are several locations with high concentrations of thorium which may have to be excavated.

Subsurface Residual Radioactivity

At this site, the thorium contamination is located below the top 15 cm of the land surface. Since the MARSSIM final status survey method was not designed for residual radioactivity deeper than 15 cm, MDNR will need to provide a distinct subsurface sampling methodology to demonstrate compliance with the unrestricted release criteria.

DP Due Date:

The licensee stated that it plans to submit a request for a one-year extension for submittal of the DP. The staff noted that the request must address the criteria in 10 CFR 40.42(i) for approval of an alternate schedule.

Content of the DP

The meeting concluded with a detailed discussion of Appendix A (Acceptance Review Checklist) to NUREG-1727. An annotated checklist was developed. The checklist was prepared under the assumption of unrestricted release. A copy of the annotated checklist is included as Attachment B. This checklist will be used by NRC staff to conduct the acceptance review of the submitted DP.

ACTIONS

MDNR stated that it plans to submit a request to extend the due date for its DP. MDNR was encouraged to submit the request as soon as possible.

Post-Meeting Note: The extension request was submitted on March 15, 2001.

Staff will review the decommissioning plan without assessing the technical accuracy or completeness of the information contained therein. The adequacy of this information will be assessed during the detailed technical review.

In most cases, licensees will not be required to submit all of the information in this checklist. Rather, the staff should use this checklist as a basis for developing a site specific checklist for the individual facility. Staff should use the checklist first during the initial meetings with licensees to discuss the scope and content of the decommissioning plan for each site. The staff, in conjunction with the licensee, should determine what information should be submitted for the site, based on the uses of radioactive material at the site, the extent and types of radioactive material contamination, the manner in which the licensee intends to decommissioning the facility and other factors affecting the potential for increased risk to the public or workers from the decommissioning operations. This information should be documented by modifying the acceptance review checklist. Copies of the modified checklist should be provided to the licensee and maintained by the Project Manager. When the decommissioning plan is submitted the Project Manager should use the modified checklist to perform the acceptance review.

Staff will review the decommissioning plan table of contents and the individual decommissioning plan chapters or sections to ensure that the licensee or responsible party has included this information in the decommissioning plan. In addition, the staff may use the guidance regarding formatting and suggested length of individual as a guide in determining if the level of detail of the information appears to be adequate for the staff to perform a detailed technical review. Staff should recognize that failure to supply an item included in the checklist does not necessarily constitute grounds for rejecting the decommissioning plan. Rather, the staff should determine if the licensee can supply the information in a timely manner and if so communicate the additional information needs to the licensee in a deficiency letter. Only in those cases where a detailed technical review cannot begin without the required information should the DP be rejected. For example, if the licensee is requesting restricted release and has not obtained the appropriate input from community interests who could be affected by the decommissioning, the decommissioning plan should be rejected during the acceptance review. Questions regarding whether to reject a decommissioning plan based on the results of the acceptance review should be forwarded to the Decommissioning Branch, Division of Waste Management.

RADIOLOGICAL STATUS OF THE FACILITY

1. Page A6, CONTAMINATED STRUCTURES, Item 2 - The second item is applicable but needs to be revised to state, " a summary of the structures and locations at the facility that the licensee or responsible party has concluded have not been radiologically impacted and the rationale for this conclusion."
2. Page A6, CONTAMINATED SYSTEMS AND EQUIPMENT, Item 1 - The first item is applicable but needs to be revised to state, " a list or description and the location of all systems or equipment at the facility that the licensee of responsible party has concluded have not been radiologically impacted and the rationale for this conclusion."
3. Page A7, SURFACE SOIL CONTAMINATION Item 1 - The first item should be revised to read, "provide a valid explanation (including radiological analysis of soil as needed) for concluding that there is no radionuclide contamination present in surface soil from facility operations supporting site characterization work." If contamination is present, the last three items in this section would also be applicable.
4. Page A7, SURFACE WATER - The first item is applicable, unless the licensee can demonstrate otherwise. Consequently, all of the items in this section are applicable.

ALTERNATIVES CONSIDERED

5. Page A9, ALTERNATIVES CONSIDERED - The licensee must address the no action alternative and related doses due to this alternative.

PLANNED DECOMMISSIONING ACTIVITIES

6. Page A10, CONTAMINATED STRUCTURES - All of the items in this section should be retained until the licensee can demonstrate otherwise in the decommissioning plan.
7. Page A10, CONTAMINATED SYSTEMS AND EQUIPMENT -All of the items in this section should be retained until the licensee can demonstrate otherwise in the decommissioning plan.

HEALTH AND SAFETY PROGRAM DURING DECOMMISSIONING

8. Page A15, Instrumentation Program - Add another item that states, "instruments will be calibrated using calibration sources that are traceable to NIST for the appropriate type and energies for the radionuclides present at the site."

ENVIRONMENTAL MONITORING PROGRAM

9. Page A16, EFFLUENT MONITORING PROGRAM - The first item “a demonstration that background and baseline concentrations of radionuclides in environmental media have been established through appropriate sampling and analysis,” needs clarification. Environmental media refers to the appropriate types of sampling to be done that are specific to the radionuclides and their interaction with the environment found at the site. For example, vegetative sampling would only be done if the radionuclide of concern was known to be incorporated. Sediment samples would be another example of environmental media. Also, under this item, the licensee needs to address the presence of radon, since this could confound sampling measurements for thorium.

10. Page A17, EFFLUENT CONTROL PROGRAM - Revise the last item to read, “a summary of the estimates of doses to the public from effluents and a description of the method used to estimate public dose per 10 CFR Part 20, Appendix B, limits.”

QUALITY ASSURANCE PROGRAM

11. Page A19, QUALITY ASSURANCE PROGRAM - The twelfth item “a commitment that persons self-assessing activities are not to have direct responsibilities in the area they are assessing,” refers to an individual in the organization who does the self-assessment but who is not the individual who actually performed the work.
