This memo is to inform you that the Shieldalloy facility in Newfield, NJ (Source Material licensee) is currently in a stand-by mode of operations, but they plan to notify the NRC that they will move into a decommissioning phase in the fall of 2001. In a letter dated July 5, 2000, the Shieldalloy license was amended to postpone the initiation of decommissioning. They have until September 1, 2001 to provide written notification of their intentions. Their Decommissioning Plan is due one year after they provide notification. They've contacted the Region and informally stated that they will not resume operations. Fuel Cycle licensing staff will plan to turn this project over to DWM after we receive formal notification from the licensee.
