FREEDOM OF INFORMATION ACT REQUEST

Pursuant 5 U.S.C. 552 and the Nuclear Regulatory Commission's (NRC's) implementing regulations at 10 C.F.R. Part 9, I would respectfully request the following NRC records pertaining to the Heritage Minerals, Inc. Lakehurst, New Jersey site, Docket No. 40-8980, Source Material License No. SMB-1541. Region I in King of Prussia, Pennsylvania, has responsibility for this site.

1. Inspection Report 99990000-89-01. Pre-licensing inspection of the Heritage Minerals, Inc. (HMI), Lakehurst, New Jersey, site. The inspection took place on January 12, 1989.


