Again I apologize I thought that I had sent this information to you immediately following our telephone conversation. Just a couple of clarifications/corrections:

The SBCCOM Commander at APG is a two star not a three star as we previously discussed - Major General Doesburg and the Natick is a one star vice a two star - Brigadier General Mattox (previously BG Mangual).

Subordinate to these authorities are the Executive Director of the Integrated Material Management Center (IMMC) at Natick, Mr. Patrick Kofalt, and the Program Manager, Nuclear, Biological and Chemical Defense, Colonel Reeves. My position is directly under Mr. Kofalt even though I am located at APG.

John Manfre is my counterpart located at our higher headquarters and has no direct authority in the SBCCOM chain of command.

From the SSD perspective, based on the levels of command as listed above, level 1 is not acceptable. Any level from 2 on up is acceptable.

Using the Natick address was done to ensure that a level of command with sufficient authority was held responsible for the certificate and its commitments. Joyce Kuykendall of the Army explained that level 3 is the actually the command level SBCCOM and levels 1 and 2 are designations within the command. In order to more accurately identify the actual command, all three certificates for vendor code 1129 are being corrected to reflect the command level at Aberdeen Proving Ground. The new address is:

This is the level that is ultimately responsible for the certificate. All future applications should come from that level. If that level wishes the applications to be signed by a designated authority below that level, then the application will clearly state that the authority has been delegated to the level signing the application. Joyce Kuykendall has stated that the invoices for these certificates should come directly to her for handling. Ms. Kuykendall has been informed that she can contact Sandy Kimberely of NRC and request that an alternate billing address be entered into the Fee Billing system.

To ensure that all parties are aware, the NRC cover letter will explain why the change is being made and copies will be sent to the commander in Aberdeen, P.Kofalt of Army MA, E.Ullrich of NRC Region I, L.Heuter of NRC Region III, J.Hull of NRC Legal Counsel, and yourself.
