During a meeting with the Chairman in September 2000 to discuss the ongoing activities associated with the Indian Point Nuclear Generating Unit No. 2 (IP2), U.S. Representative S. Kelly of New York asked several questions that were outside the scope of the meeting. These questions involved: (1) the Ramapo Fault, (2) leakage of water from the IP Unit No. 1 spent fuel pool, and (3) emergency preparedness. Because of the Chairman's desire to reply to Representative Kelly in a timely manner, he forwarded these questions informally to the staff. Likewise, the staff provided the answers without a transmittal memorandum. However, the information that comprised the answers was incorporated into a Commission briefing package dated November 28, 2000, in preparation for a visit by corporate officials from Consolidated Edison of New York, Inc.

Task Activity Code (TAC) No. MB0189 was opened to account for the staff resources allocated to development of the answers. At the time, the staff also had the expectation that additional details or questions might arise when the answers were forwarded to Representative Kelly. However, the staff has not been requested to provide any followup action to date. In addition, no commitment to provide additional information is currently open in the Work Item Tracking System maintained by the Office of the Executive Director for Operations.
