IMPLEMENTATION OF NUCLEAR SAFETY AND SECURITY  
ASSISTANCE PROJECTS

On Friday, March 23, Vadym Gryschenko, Chairman of the State Nuclear Regulatory Committee of Ukraine (SNRCU) and the EDO signed the attached Memorandum of Meeting (MOM) describing the NRC-SNRCU program of assistance. The MOM summarizes progress made over the last year between our agencies and plans for the next year.

The program in the MOM was developed in light of the terms and conditions of the loan by the European Bank for Reconstruction and Development (EBRD) for completing the two reactors under construction, Khmel'nitsky 2 and Rivne 4 (K2/R4). The condition relevant to our program is the commitment by the G-7 to provide appropriate technical assistance to assure that these two reactors, and all other operating reactors in Ukraine, adopt Western safety standards. Ongoing or planned activities are consistent with this condition.

All agreements in the MOM were made with the understanding that they are subject to the availability of funds.
