Dear Mr. Lochbaum:

Your letter dated March 15, 2001, requests that the Special Inspection Team (SIT) reviewing the loss of offsite power event at Seabrook address certain topics described in the letter.

Some of the issues you raise will be addressed by the SIT. Specifically, the actions taken by the licensee in preparation for the severe weather and in response to the degraded offsite power, as well as the impact that the severe weather had on the alert and notification system, will be reviewed by the Special Inspection Team. We expect to provide you a copy of the Special Inspection Team report by May 15, 2001.

The question about operating Seabrook under adverse weather conditions has been previously addressed by the NRC. I have enclosed a copy of a letter to the Seacoast Anti-Pollution League that discussed Seabrook's operation during a winter storm in 1993. That letter reflects the staff's current position regarding this question. In closing, let me assure you that the NRC carefully followed the storm at Seabrook. The NRC staff was in contact with the Seabrook station and monitored licensee contingency planning and the progress of the storm, as well as the licensee's actions in response to the storm-related plant transient. An NRC inspector responded to the site during the storm, arriving coincident with the plant transient, monitored the licensee's actions in response to the transient, and maintained communications with a senior manager in the Region I office.
