

The purpose of this modification is to provide incremental funding in the amount of \$40,000 to allow for the continuation of work in Option Year 2 , thereby increasing the obligation amount of this contract from \$277,899.00 to \$317,899.00. Accordingly, the contract is hereby modified as follows:

Under Subsection B.3, "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988)," paragraph (g) is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"(g) The amount currently obligated by the Government with respect to this contract is \$317,899.00."

All other terms and conditions remain unchanged, including the ceiling amount of \$369,603.00.
