


The purpose of this modification is (1) to exercise Option Year 4 in accordance with Section I.4 under the subject contract; (2) obligate the guaranteed minimum of \$25,000 for Option Year 4 in accordance with Section B.3, subparagraph j; and (3) increase the ceiling amount by \$233,869.61 from \$892,225.18 to \$1,126,094.79. Accordingly, the contract is hereby modified as follows:

Section F.6, Duration of Contract Period (Mar 1987) Alternate IV (Jun 1988) is deleted in its entirety and replaced with the following:

"The period of performance shall commence on March 19, 1997 and continue through March 18, 2002."

All other terms and conditions of the contract remain unchanged.
