

The purpose of this modification is to 1) Modify the Statement of Work to provide for the production of CD-ROM copies of documents available electronically in ADAMS database or from PDR diskettes and the reproduction of colored pages and drawings; 2) Modify the Schedule of Items to include the pricing, estimated quantities, maximum quantities and processing times for the production of CD-ROM copies of documents available electronically in ADAMS or from PDR diskettes and the reproduction of colored prints and drawings; and 3) Increase the estimated total amount for Base Period and Option Period of the contract to reflect the addition of these new line items. Accordingly, the contract is hereby modified:

1. Section B.3, is modified to add two new line items as follows:

The "ESTIMATED TOTAL AMOUNT FOR THE OPTION PERIOD" is increased to \$506,480.50.

2. Section B, is modified to add new subsections, Subsection B.9.17 and B.9.18, as follows:

"B.9.17 ELECTRONIC FULL TEXT DOCUMENTS TO CD-ROM

The Contractor shall produce CD-ROM copies of NRC documents available electronically in the ADAMS database or from PDR diskettes. The Contractor shall have the ability to produce duplicate copies of ADAMS documents or PDR diskettes on CD-ROM including all text, image, sound and/or motion contained in the original file. If requested, multiple documents will be copied onto a single CD-ROM. Documents will only be copied electronically in their entirety, no requests for partial documents or section will be honored. If a document or documents exceed the capacity of a CD-ROM, a second CD-ROM shall be started. The CD-ROMs produced must conform to ISO standards and must be playable on all standard platforms (UNIX, Windows and Macintosh).

Each CD-ROM shall be clearly labeled to identify the contents of the CD-ROM (for example the ADAMS accession numbers of all documents copied onto the CD-ROM). Each reproduced CD-ROM must be placed in a jewel case.

Reproduced CD-ROMs shall be subject to the same mailing options and delivery times as other media (e.g., U.S. Mail, Federal Express). Special protective packaging (jewel cases, bubble-wrap) shall be required to insure that the contents arrive undamaged.

Pricing and turnaround times will be per document regardless of the number of pages. Additional documents from ADAMS may be, by request, placed on same CD-ROM for an additional fixed price per document.

B.9.18 COLOR PRINTS AND DRAWINGS

The contractor shall reproduce color prints and drawings per the request of the customer. The contractor is advised that it is the sole responsibility of the customer to notify the contractor that color prints or drawings are to be reproduced and shall also notify the contractor which color prints or drawings in the document are to be reproduced."

This modification obligates no funds.

All other terms and conditions of the subject contract remains unchanged.
