RENEWAL GUIDANCE DOCUMENTS

On April 18, 2001, after the License Renewal Steering Committee public meeting, I was requested by Mr. Doug Walters of the Nuclear Energy Institute (NEI) to discuss the industry's plan for the "demonstration project" to implement the improved license renewal guidance documents. Mr. Joe Gasper of the Omaha Public Power District was also present at the discussion.

The staff planned on issuing improved license renewal guidance documents: Generic Aging Lessons Learned (GALL) report, Standard Review Plan for License Renewal (SRP-LR), and Regulatory Guide for License Renewal (endorsing NEI document 95-10, as appropriate). In a January 31, 2001, public meeting, NEI proposed, and the staff concurred, that it would be beneficial to resolve implementation issues of these documents through a demonstration project.

NEI indicated that the industry participants would be preparing sample portions of a license renewal application following the guidance in the improved license renewal guidance documents (August 2000 for public comment version). The participants would compare their aging management evaluation with that in the GALL report and "roll up" the results into a format consistent with the SRP-LR and the example in the staff's February 3, 2000, letter to NEI. The "roll up" would be submitted as sample portions of a license renewal application and the supporting information would be considered on-site documentation available for staff audit or inspection. NEI indicated that we should plan a public meeting in late April or early May to discuss their demonstration project.
