Yankee Atomic Electric Company (YAEC) is preparing to transfer spent fuel from the Yankee Nuclear Power Station (YNPS) Spent Fuel Pool to a dry cask storage facility beginning in the summer of 2001. In support of this activity, YAEC requested Nuclear Regulatory Commission (NRC) review and approval of an amendment to the YNPS Security Plan (References (c) and (d)). YAEC hereby submits a revised Attachment A to the proposed Security Plan in response to a request for additional information resulting from NRC's technical review (Reference (e)). Changes to the attached plan are identified by revision bars in the left margin.
