Thank you for your letter of April 10, 2001. It was a pleasure to welcome you for the first time to NRC for our annual program planning meeting.

Your letter described the "Concept of the SNRCU Emergency Response," consisting of two areas on the same floor: the center proper and the normal working places for experts to be involved in emergency response. I think it is an excellent concept which should increase the efficiency of your staff when responding to emergencies.

As you noted, NRC agreed to "endeavor to fund the portion of the project pertaining to the transfer of the IEC." This portion appears to cover approximately the same area as the "center proper," which includes rooms 517, 520, 521, 522, and 523 in the diagram attached to your letter. We will try to allocate funding to move the existing IEC to these rooms or the approximate equivalent, provided that they are functionally suitable. I regret to say that we will not be able to fund renovation of the rooms which you designate as "Expert Rooms." However, we will continue our endeavors to support continuity of critical SNRCU emergency response capabilities.
