SUBJECT: DISPERSAL OF TITLE X FUNDS TO THE MOAB MILL RECLAMATION TRUST.

Dear Mr. Fiore:

This is to request that you delay dispersal of funds, under Title X of the Energy Policy Act of 1992 to the Moab Mill Reclamation Trust (Trust). The Trust holds U.S. Nuclear Regulatory Commission (NRC) Materials License No. SUA-917 as the successor to Atlas Corporation and is entitled to reimbursement for costs of reclamation of its uranium mill tailings under Title X. NRC and the State of Utah are the beneficiaries of the Trust. We understand that you are preparing to disperse the annual Title X reimbursement to the Trust shortly and we request that you delay that dispersal pending resolution of certain issues we have with the trustee, Mr. William Abington, a partner in PricewaterhouseCoopers LLP.

By letter dated March 30, 2001, NRC identified activities that it requested the trustee to perform at the site. The trustee has not yet agreed to perform those activities. The trustee had expressed concern about performing those activities because of potential liability under the Endangered Species Act. The trustee has been in discussion with officials at the U.S. Department of the Interior to resolve those concerns but has not yet reached resolution. We will notify you when we believe it is appropriate to disperse the Title X payment to the Trust.
