On October 12, 2000 CE Nuclear Power, LLC will commence the shipment of 640 gadolinium burnable absorber rods from its Hematite, Missouri fuel fabrication facility to the KEPCO Nuclear Fuel Company under NRC License No. XSNM02258, Amendment 03. The material to be shipped is contained in 640 unbound Zircaloy clad rods containing approximately 1,098 KgU as natural uranium dioxide, with each rod containing approximately 6 weight percent gadolinium (GD_2O_3) poison. The KEPSCO Nuclear Fuel Company will assemble the rods into fuel bundles to be used as reload fuel for the Yonggwang Unit 4 reactor.

The cargo will be transported by truck from Hematite, Missouri to Los Angeles, CA and then transported via air to South Korea. The shipment is expected to depart Hematite on Thursday, October 12, 2000 and arrive at the Korean Airlines Cargo Terminal in Los Angeles, California by October 14. Transport to South Korea via air will occur shortly afterwards.
