AMENDED NOTICE OF DEPOSITION FOR LEON D. BEAR


Pursuant to an agreement between PFS and OGD, and 10 C.F.R. §§ 2.740(b), 2.740a, and Federal Rules of Civil Procedure 26(b) and 30, Ohngo Gauded Ahdevia ("OGD") will take the deposition under oath of **Mr. Leon D. Bear**. Mr. Bear is the author of a letter and attachment dated February 16, 1999, submitted to the Nuclear Regulatory Commission ("NRC") by Private Fuel Storage ("PFS" or "Applicant") on February 18, 1999, as a response to an EIS Request for Additional Information.


