[REDACTED] received a complaint filed by you, alleging that you were subjected to discrimination by Carolina Power and Light Company's (CP&L) Harris Nuclear Plant for engaging in a protected activity. The NRC notified you by copy of a letter to CP&L, dated October 19, 1998, the results of the NRC's Office of Investigation's (OI) review of this matter. The NRC's October 19, 1998 letter also informed you and CP&L that the NRC staff would hold its final judgement on whether or not enforcement action was warranted in this matter until after an adjudicatory decision by a DOL Administrative Law Judge (ALJ). 7C

[REDACTED] the DOL ALJ issued a Recommended Order of Dismissal in the case approving the settlement of your complaint with CP&L. Based the RDO and that the settlement met the requirements of 10 CFR 50.7, the NRC staff's monitoring of DOL activities has been completed. 7C
