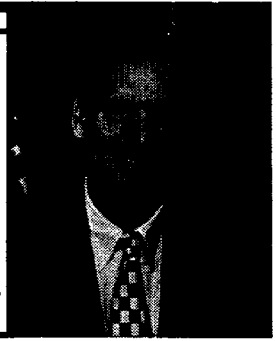

CHAIRMAN GREGG BEGINS SERIES OF HEARINGS ON DOMESTIC TERRORISM

Day One of three-day hearings to address federal readiness includes Powell, O'Neill, and Mineta

(Washington, DC) – U.S. Senator Judd Gregg (R-NH) today began a series of hearings to assess the capabilities of United States federal agencies for preventing, preparing for, and responding to acts of terrorism. Eighteen government officials have been asked to testify over the three-day period, including Secretary of State Colin Powell; Secretary of the Treasury Paul O'Neill; and the Secretary of Transportation Norman Y. Mineta all testifying on Tuesday. Scheduled to testify later in the week are the Secretary of Health and Human Services Tommy G. Thompson; the Secretary of Commerce Donald L. Evans; the Secretary of Agriculture Ann M. Veneman; and the Attorney General John Ashcroft.

Senator Gregg serves as the Chairman of the Senate Appropriations Subcommittee on Commerce, Justice, State, and the Judiciary (CJS). As an overseer of the budget for the Department of Justice, the lead agency for domestic terrorism, Senator Gregg has expressed concerns about the current level of preparedness of the over forty federal agencies responsible for one aspect of dealing with domestic terrorism.

"During my tenure as Chairman of CJS," Gregg stated, "I have read numerous reports that detail the difficulty federal agencies face in determining what their responsibilities in dealing with terrorism are and how they can best meet those obligations. Our intention with these hearings is to learn what federal agencies perceive their responsibilities to be and how well they are coordinating with other federal agencies working on the same problems. The hearings will be an important first step to begin coordinating federal efforts into one coordinated, united response."

Also participating in this week's hearings will be Senator Ted Stevens (R-AK), Chairman of the Appropriations Committee, Senator John Warner (R-VA), Chairman of the Armed Services Committee, Senator Richard Shelby (R-AL), Chairman of the Select Committee on Intelligence, and Senator Pat Roberts (R-KS), Chairman of the Armed Services Subcommittee on Emerging Threats and Capabilities.
