In accordance with Section G.5, of the subject contract entitled, "Task Order Procedures," this letter definitizes Modification No. 3 to Task Order No. 2 which (1) extends the period of performance through June 30, 2001, and (2) increases the amount of the task order by \$4,586.17 from \$28,007.70 to \$32,593.87. This effort shall be performed in accordance with the enclosed Statement of Work. Accordingly, the task order is hereby revised as follows:

The second paragraph of the basic task order is deleted in its entirety and the following paragraph is substituted in lieu thereof.

"The period of performance for Modification No. 3 to Task Order No. 2 shall be from April 2, 2000, through June 30, 2001, with a cost ceiling of \$32,593.87."


