LICENSE RENEWAL APPLICATIONS - SUBMITTAL

Pursuant to the requirements of Parts 50, 51, and 54, Virginia Electric and Power Company (Dominion) hereby applies for the renewal of the operating licenses for Surry and North Anna Power Stations, Units 1 and 2. The current operating license for Surry Unit 1 (DPR-32) expires on May 25, 2012, and the license for Unit 2 (DPR-37) expires on January 29, 2013. The current operating license for North Anna Unit 1 (NPF-4) expires on April 1, 2018, and the license for Unit 2 (NPF-7) expires on August 21, 2020. This application meets the timeliness requirements in 10 CFR 2.109(b) and 54.17(c). Dominion requests that the operating license for each of these units be extended for twenty (20) years.

The enclosed license renewal applications for Surry and North Anna Power Stations contain the information required by 10 CFR 54.17, 54.19, 54.21, 54.22, 54.23, and 51.53 for the contents of an application including an environmental report.

In an NRC letter dated September 21, 2000, the NRC granted Dominion an exception to 10 CFR 50.4 to allow CD-ROMs to be submitted instead of paper to meet the copy requirements under 10 CFR 50.4(b)(3), 50.4(b)(2)(ii), 50.30(a)(2), 51.55(a), and 2.101(a)(3). As permitted by the exception, the original license renewal applications and 37 CD-ROM copies are provided to fulfill both the requirements of 10 CFR 50.4(b)(3) for acceptance review and the subsequent copies required by 10 CFR 50.4(b)(2)(ii), and CD ROM copies are also being provided to the Regional Administrator and the appropriate Resident Inspectors. As further permitted by the exception, an additional 41 copies of the CD-ROM are provided to meet the requirements of 10 CFR 51.55(a). Copies of the CD-ROM are also being provided to individuals and officials designated in the distribution of this letter, including the chief executive of the local government in accordance with 10 CFR 2.101(a)(3).
