The attached e-mail from Ameren Union Electric Company, the licensee for Callaway Plant, Unit 1, stated that the following licensing actions have been implemented and provided the following implementation dates: (1) Amendment No. 139 on November 11, 2000 (TAC No. MA6482); (2) Amendment No. 137 on April 25, 2001 (TAC No. MA9080); (3) emergency plan change on March 29, 2001 (TAC No. MA9748); (4) Amendment No. 141 on April 25, 2001 (TAC No. MB0587); (5) Amendment No. 142 on May 14, 2001 (TAC No. MB0594); (6) Amendment No. 143 on May 17, 2001 (TAC No. MB1038); and (7) Generic Letter (GL) 75-07 on May 21, 2001 (TAC No. M93443).

For Amendment No. 144, the licensee estimates that the amendment will be implemented by June 1, 2001 (TAC No. MB1022).

For GL 96-06 (TAC No. M96971), the staff issued the letters closing out (1) the waterhammer and 2 phase flow aspects of the generic letter on November 30, 1999, and (2) the thermally induced overpressurization of piping systems penetrating containment aspects of the generic letter on February 28, 2000. Therefore, all aspects of GL 96-06 have been resolved to the satisfaction of the staff, and the licensee has implemented the generic letter on October 29, 1999 (TAC No. M96971).

M93443			[5/21/01 C]	NRC Generic Letter 75-07 (8/17/95). The last UE letter was ULNRC-04074 (7/28/99). NRC approved by letter dated 9/7/99. Modifications were completed in Refuel 11 rather than Refuel 12.

				The completion date for Refuel 11 is 5/21/01. The referenced NRC letter also asked for a letter from us with 3 months of completing the work. I will send a letter soon.

Note 1: Implemented internally on 11/17/00. FSAR CN 99-039, Tech Spec Bases CN 00-035, and associated procedure changes were implemented at that time. The retyped FSAR pages will be included in the November 2001 (OL-12) FSAR update. The retyped Tech Spec Bases pages were provided to NRC in Bases Revision 1.

Note 2: ULNRC-04461 dated 4/25/01 informed NRC that Amendments 137 and 141 were both implemented on 4/25/01. FSAR CN 00-001, Tech Spec Bases CN 00-034, and associated procedure changes were implemented on 4/25/01 for Amendment 137. FSAR CN 00-070 and associated procedure changes (no Tech Spec Bases changes required) were implemented on 4/25/01 for Amendment 141. The retyped FSAR pages will be included in the November 2001 (OL-12) FSAR update. The retyped Tech Spec Bases pages will be provided to NRC in the next Bases revision.

Note 3: Callaway Monthly Licensing Status Reports dated 3/30/01 and 5/3/01 identified 3/29/01 as the implementation date for these RERP changes.

Note 4: ULNRC-04479 dated 5/18/01 informed NRC that Amendment 142 was implemented on 5/14/01 (60 days from LA issuance), but the revised 50.59 rule will not be implemented until 7/31/01.

Note 5: This amendment will be implemented prior to 6/5/01 (60 days from LA issuance), with a tentative date of 6/1/01 assigned. The plant-specific license commitments will be completed by November 29, 2001. The PASS system will be retired in place by 12/31/01, with the exception of the containment isolation valves that will be removed during the next refueling (12) outage.

Note 6: ULNRC-04478 dated 5/18/01 informed NRC that Amendment 143 was implemented on 5/17/01. The retyped FSAR pages will be included in the November 2001 (OL-12) FSAR update.
