

## NUCLEAR ENERGY LIABILITY INSURANCE ASSOCIATION

### CHANGES IN SUBSCRIBING COMPANIES AND IN THEIR PROPORTIONATE LIABILITY ENDORSEMENT CALENDAR YEAR 2001
