
Duke Cogema Stone & Webster ("DCS") hereby submits its Answer to Edna Foster's Request for Hearing regarding the Mixed Oxide Fuel Fabrication Facility ("MOX Facility") Construction Authorization Request ("CAR").

Ms. Foster's Request for Hearing is a handwritten, two-sentence letter stating only that she requests a hearing "on the mixed oxide fuel facility and the future use of MOX at Oconee, S.C. which is quite near us."¹ The Request is, on its face, insufficient to satisfy the essential, minimum requirements for legal standing to obtain a hearing regarding the MOX Facility CAR. Indeed, it appears that Ms. Foster resides in

Highlands, N.C. over 130 miles from the MOX Facility.² Accordingly, this Request for Hearing should be summarily denied.³


