On May 31, 2001, NRC Region III staff members met with Mr. J. Cotton and others of your staff in the Region III office, Lisle, Illinois. The purpose of the meeting was to discuss recent reactor recirculation system problems at the Dresden and Quad Cities stations. Your staff presented a detailed briefing on the Dresden reactor recirculation system problems including your corrective actions. We understand that you plan to apply any generic implications from the Dresden review to other Exelon facilities where applicable. Enclosure 1 is the attendance list for the meeting.
