



The purpose of this modification is to provide incremental funding in the amount of \$36,000.00, thereby increasing the contract's obligated amount from \$109,000.00 to \$145,000.00. Accordingly, the contract is hereby modified as follows:

Under Subsection C.11 entitled "CONSIDERATION AND OBLIGATION-DELIVERY ORDERS" (JUN 1988), the first sentence of paragraph (b) is deleted in its entirety and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$145,000.00."

All other terms and conditions of the contract remain unchanged, including the ceiling amount of \$174,650.00.
