This letter confirms the conversation between Mr. Jeff Gasser of your staff and Mr. John Zeiler of this office on June 7, 2001, concerning an Annual Assessment Meeting requested by us which is scheduled for July 17, 2001, at 3:00 p.m. (EDST). The purpose of the meeting is to discuss the NRC Reactor Oversight Process Annual Assessment of your Vogtle Nuclear Plant. During the meeting, we recognize that you may have information you want to present to us or any members of the public in attendance. Accordingly, if you so desire, after our presentation you will be afforded an opportunity to respond to any information contained in the Annual Assessment Letter and to discuss any new or existing programs that are designed to maintain or improve your current performance. The location of the meeting will be the Plant Vogtle Administrative Building 1<sup>st</sup> Floor Auditorium at 8805 River Road, Waynesboro, Georgia.

Additionally, a separate meeting will be held with state and local government officials at the same location shortly after the conclusion of the Annual Assessment Meeting. The purposes of this meeting are to discuss the regulatory role of the NRC, the role of the Vogtle resident inspectors, and the avenues that are available to bring concerns to the NRC. Both meetings are open meetings as per "Staff Meetings Open to the Public; Final Policy Statement" (September 20, 2000; 65 FR 56964).

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
