This letter is provided to correct an error in our 12 July 2001 response to your request for additional information on the Mixed Oxide Fuel Fabrication Facility Environmental Report. In answering question 24 d (page 24), the response incorrectly provides the diesel fuel consumption for the period of construction as the annual consumption. The diesel fuel consumption during construction is 580,000 gallons (2,195,200 liters). The correct annual consumption is 232,240 gallons per year (599,809 liters per year). Please revise the response to change 580,000 gallons per year (2,195,200 liters) to 232,240 gallons per year (599,809 liters per year).
