MEMORANDUM AND ORDER  
(Revised General Schedule)

The Licensing Board has before it the September 10, 2001 joint scheduling report of applicant Private Fuel Storage, L.L.C., (PFS), intervenor State of Utah (State), and the NRC staff, arrived at in consultation with intervenors Ohngo Gaudadeh Devia (OGD) and Southern Utah Wilderness Alliance (SUWA), in which the parties provide a proposed general schedule that encompasses litigation of the remaining admitted contentions regarding the pending PFS application for its proposed Skull Valley, Utah 10 C.F.R. Part 72 independent spent fuel storage installation. As the report notes, the proposed schedule is based on the assumption that the staff will issue safety evaluation report supplements on aircraft crash and geotechnical issues on November 13, 2001 and December 21, 2001, respectively, and that the final environmental impact statement will be issued on December 21, 2001. In addition, the State has requested that prefiled testimony not be due during the period of February 8-24, 2002, when the Winter Olympics will make work in downtown Salt Lake City difficult. As the report also notes, there is one dispute that must be resolved relative to the proposed schedule -- the date for the prefilings of testimony relative to contention Utah K/Confederated Tribes B, Inadequate Consideration of

Credible Accidents. PFS and the staff assert these submissions should be due on or before February 8, 2002, while the State asks that the filings be scheduled for March 11, 2002, along with the other outstanding Groups I-II/B issue, contention Utah L, Geotechnical.

The Board appreciates the efforts evidenced by the parties in arriving at a proposed revised schedule. After reviewing their submission, and noting the parties' understanding as expressed in footnote three of their joint report relative to formal discovery on new material regarding contention Utah L, we adopt the attached revised general schedule as set forth in Attachment A. In doing so, we establish the date for prefiled testimony relative to contention Utah K/Confederated Tribes B as Friday, February 8, 2002. We take this step because the Board's opportunity for a thorough review of the parties' submissions will be aided materially by having this testimony filed in early February rather than in mid-March when the balance of the prefiled testimony is to be submitted. Also, the Board has revised the date upon which it will render its decisions regarding the five pending Group III summary disposition motions to Friday, November 16, 2001, although it does not anticipate that this entire period will be needed for

rulings on all the pending dispositive motions (including that relating to Group I/II-B issue contention Utah L, Basis A).

It is so ORDERED.
