This report transmits the results of the senior reactor operator (SRO) licensing examination conducted August 13, 2001. This examination addressed areas important to public health and safety and was developed and administered using the NRC guidelines of the "Examination Standards for Power Reactors" (NUREG-1021, Revision 8, Supplement 1).

Based on the results of the examination, the SRO applicant passed the written retake examination. The final exam result was given during a telephone call on August 21, 2001.

## SUMMARY OF FINDINGS

IR 05000277/01-301; on August 13, 2001; Peach Bottom Atomic Power Station; Initial Operator Licensing Written Retake Examination. One of one SRO applicant passed the written examination.

The written examination was administered by the facility licensee. There were no inspection findings associated with the examination.

## Report Details

### 1. **REACTOR SAFETY**

#### Mitigating Systems - Reactor Operator (RO) and Senior Reactor Operator (SRO) Initial License Examinations

##### a. Scope of Review

The NRC examination team reviewed the written (RO and SRO) initial examinations submitted by the Peach Bottom training staff to verify or ensure, as applicable, the following:

- The examinations were prepared and developed in accordance with the guidelines of Revision 8, Supplement 1, of NUREG-1021, "Operator Licensing Examination Standards for Power Reactors" and they met the overall quality goals (range of acceptability) of these standards. The review was conducted in the Region I office. Final resolution of comments and incorporation of revisions was conducted during and following a telephone call on July 19, 2001.
- Facility licensee completed a test item analysis on the written exam for feedback into the systems approach to training program.
- Examination security requirements were met.

The written examination was administered by the Peach Bottom training staff on August 13, 2001.

##### b. Findings

#### Grading and Results

The SRO applicant passed the initial written retake examination.

The facility had no post-examination comments.

#### Examination Preparation and Quality

The examinations met the quality goals of NUREG-1021, Revision 8, Supplement 1.

#### Examination Administration and Performance

The RO written retake examination was not administered.

The facility licensee provided remediation on the missed subject areas during the post examination review.

#### 4OA6 Exit Meeting Summary

On August 21, 2001, the NRC provided conclusions and examination results to a Peach Bottom management representative, via telephone. The license number for the applicant who passed the exam was also provided during the telephone call.

The NRC expressed appreciation for the cooperation and assistance that was provided during the preparation and administration of the exam by the licensee's training staff.
