By letter dated August 24, 2001, Entergy Nuclear Generation Company (ENGCO) applied for an order consenting to the transfer of the operating authority for the Pilgrim Nuclear Power Station (Pilgrim) Facility Operating License No. DPR-35 and transfer of Materials License 20-07626-04 to Entergy Nuclear Operations, Incorporated (ENO). The letter stated that ENGCO would remain the owner of Pilgrim and would enter into an Operating Agreement with ENO. You requested that the change in the Pilgrim operating license and materials license become effective on December 28, 2001.

The Nuclear Regulatory Commission (NRC) staff has considered your requested effective date, taking into account the number of license transfer applications currently under review by the NRC, and has determined that we will not be able to complete the reviews of your application in time to meet the requested effective date of December 28, 2001. We currently anticipate that we will be able to complete our evaluation of the ENGCO application and, if acceptable, issue the appropriate order by February 28, 2002. However, at the end of December 2001 we will reevaluate our progress toward achieving the February 28, 2002, date and will notify you in early January 2002 if we need to make further changes to our anticipated effective date.
