


The purpose of this modification is to deobligate funds in the amount of \$34,000.00, thereby decreasing the obligated amount of the contract from \$387,800.00 to \$353,800.00.

Accordingly, the contract is hereby modified as follows:

Under Subsection B.4 - CONSIDERATION AND OBLIGATION--DELIVERY ORDERS, the first sentence in paragraph (b) is deleted in its entirety and the following is substituted in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$353,800.00."
