

The purpose of this modification is to obligate FY'01 funds in the amount of \$4,480.00, thereby increasing the obligated amount of the contract from \$99,000.00 to \$103,480.00.

Accordingly, the contract is hereby modified as follows:

Under Subsection B.3 - CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE, Paragraph (m) is deleted in its entirety and the following is substituted in lieu thereof:

"(m) The amount currently obligated by the Government with respect to this contract is \$103,480.00, of which the sum of \$97,622.64 represents the estimated reimbursable costs, and of which \$5,857.36 represents the fixed fee."

A summary of obligations for this contract, from date of award through the date of this action is provided below:

Total FY'00 Obligations.....	\$39,000.00
Total FY'01 Obligations.....	\$24,480.00

Cumulative Total of NRC Obligations: \$103,480.00

This modification obligates FY'01 funds in the amount of \$4,480.00.

All other terms and conditions under this contract including, the ceiling amount of \$147,029.56 remains unchanged.
